Without A Paddle traverses the magnificent **unpaved** roads in Houston County, Minnesota. The terrain is very hilly and twisty. If you enjoy brisk rallies on unpaved roads you don't want to miss this.

Without A Paddle is a 'Map Carlo' style rally. It's similar to a Monte-Carlo where you are given the mileage to a control and the time to be there. Here's how it works. You'll receive several maps with multiple 'map points' marked on them and a timing chart with the time you should be at each map point. You'll follow the route by going to each map point, trying to get there exactly at the time specified. Now here's the challenge, you cannot stop within sight of any map point. You'll have to pay attention to where you are 'on the map' and drive accordingly.

The start location for **Without A Paddle** is at the **Crescent Inn, 444 N. Walnut St.** on the North edge **La Crescent, MN**, just off Highway 61. **Registration** is from **12:45 PM – 1:45 PM**. The 1st car begins at **2:00 PM** and subsequent cars start at 1 minute intervals. There'll be several short breaks during the rally. The finish is back at the **Crescent Inn** around **7:00 PM**. There are three competition classes: **Expert (E)** for those that have accrued less than 5 SCCA Life Time Points, **Limited (L)** for those that have competed in more than r rallies in the past 3 years, and **Sportsman (S)** for those that have competed in less than 3 rallies in the past 3 years. Due to the nature of this rally **special rally equipment** offers no significant advantage so you are free to use the equipment of your choice.
